SHIPPED SEMEN PROCEDURE

1. Prior to shipping: The stallion service fee and semen shipping fee must be paid in full prior to shipment. The shipping fee shall be \$300.00 per shipment via Fed-Ex for overnight delivery.
2. Ordering must be done the day before Oklahoma City Equine Clinic collects semen. Any order placed the day of collection is not guaranteed to receive semen. Fed-Ex usually picks up at the clinic by 1:00 p.m. (Central Time).
3. Shipped semen may only be requested to ship on regularly scheduled breeding days. Monday, Wednesday and Friday are breeding days.
No Exceptions.
4. Semen will be shipped in a disposable container.
5. Management of cooled semen is an intense process for a mare owner. If you are not in a position to have a qualified equine veterinarian palpate and ultrasound your mare daily during her heat cycle, we strongly recommend you transport her to the closest facility possible.
6. Please remind your veterinarian to complete the AQHA Insemination Report that will be sent with your semen shipment, and return the pink copy to *Etbauer Performance Horses* promptly. You will be unable to register your foal until this document is properly executed.
7. Good communication between all parties is vital to the successful shipment of cooled semen and the insemination process - please feel free to contact us should you have any questions.

This certifies _____, herein referred to as Mare Owner, has engaged one breeding to the stallion _____ AQHA Reg. No. _____ for the _____ breeding season at \$ _____ for the Mare _____, Registration Number _____.

This service is engaged subject to the following conditions:

1. The Stallion Fee includes a non-refundable booking fee of \$500, payable with this contract, and will be applied against the above breeding fee. The balance must be paid with all other expenses, including vet charges, at time mare is picked up or before time of semen shipment.
2. A copy of the mare's registration papers and proof of negative coggins is required.
3. The mare owner shall deliver the mare in a healthy and sound breeding condition. Breeder's veterinarian will examine mare for normal breeding conditions and administer medical care as deemed necessary. All vet expenses are mare owner's responsibility.
4. Mares that are not halter broken, and reasonably safe for handling and breeding, will not be accepted.
5. Stallion owner, manager of stallion, or veterinarian will not be liable for accident, sickness or death of said mare and/or foal, but will exercise his best judgment in the care of said mare and/or foal.
6. It is further agreed that should the above stallion die or become unfit for service, or should the above mare die or become unfit to breed, then this contract shall become null and void and the deposit will be returned.
7. Live foal guarantee. Live foal shall be defined as a foal that stands and nurses without assistance. Should foal not stand and nurse, mare owner agrees to notify stallion owner within one week of foaling date and furnish a statement from a licensed veterinarian. The mare owner will be entitled to return privilege with this same mare unless otherwise mutually agreed.
8. In the event that the mare aborts, the mare owner shall certify to the breeder that the mare was accurately and properly administered vaccines to prevent the mare from aborting such as booster rhinopneumonitis vaccinations administered as indicated by the individual drug manufacturer. Mares vaccinated properly will be entitled to return privilege.
9. It is understood that only one foal can be conceived from this mating.
10. Stallion Service Certificate will be issued only after mare owner has notified stallion owner that said mare has produced live foal and all bills on mare have been paid. Breeder agrees to diligently try to settle said mare up to and including July 15, unless otherwise arranged. Mare owner agrees to give breeder ample opportunity to settle mare (having bred her through at least two heat cycles, or being certified in foal by a veterinarian). If however, for any reason mare does not settle, mare owner will hold stallion owner harmless.

When mare owner and breeder sign this contract, it will be binding on both parties subject to the above terms and conditions.
